The Issuer is a Canadian gold exploration company based in Vancouver. The Issuer seeks exciting data rich gold projects with low capital requirements. The Issuer holds a 100% interest in three Canadian gold projects, the Sixtymile Project located in within west-central Yukon Territory, the New Brenda project located in the Similkameen, Nicola, and Osoyoos Mining Divisions, BC and the Ashuanipi Project located 30 to 90 kilometres west and north-west of Schefferville, Quebec,

and within the Ashuanipi Complex in the northeastern portion of the Superior Province, Quebec.

2. Provide a general overview and discussion of the activities of management.

During the month of **May 2021**, management's principal activities consisted of announcing preparations for a drill program at the Sixtymile Project. The Issuer is planning a 15-hole RAB drill program which will commence on June 22 with Dawson City based GroundTruth Exploration. The drill campaign will focus on two prospective areas: Upper Glacier Creek and the Easter Egg target.

3. Describe and provide details of any new products or services developed or offered. During the preceding month of **April, 2021**, the Issuer signed an agreement with Go Metals Corp. ("Go Metals") on the Ashuanipi gold project in eastern Quebec near the Labrador Border in the traditional territory of both the Innu and Nation of Matimekush-Lac John and the Naskapi Nation of Kawawachikamach. Under the terms of the agreement, Go Metals will earn in on the project through funding exploration. The terms are as follows:

- \$200,000 exploration dollars will earn 40%
- \$200,000 exploration dollars will earn an additional 20%
- Go Metals has the option to create a Joint Venture or it may spend an additional \$400,000 to earn a final 20% in the project.

The transaction with Go Metals is a related party transaction as Go Metals and the Issuer have certain directors and management in common.

There were no acquisitions of new customers or loss of customers during the month of **May 2021**.

**COVID-19**

The outbreak of the corona virus pandemic has impacted the Issuer’s plans and activities.
