On July 25, FogChain Corp. ("FogChain" or the "Company") entered into a non-binding letter of intent ("**LOI**") dated July 25, 2019 with Loop Media, Inc. ("**Loop Media**") pursuant to which the parties will complete a merger or some

other form of business combination that will constitute a reverse takeover of the Company by Loop Media (the "**Transaction**"). The Transaction will be considered a fundamental change within the meaning of the policy 8 of the Canadian Securities Exchange Inc. (the "CSE") policies. The resulting issuer (the "Resulting Issuer") upon completion of the Transaction will change its name to Loop Media Ltd or some other name as acceptable to the parties and will operate the current business of Loop Media.

Business activity in Sept was focused mainly around the continued development of Quilmont, RadJav, and the App Monitoring products in to a unified platform called Trident. Efforts were also made on the definitive agreement for the Loop Media transaction.
