ESI is a pipeline equipment rental and sales company with principal operations in Leduc, Alberta and Phoenix, Arizona. The Company currently operates in most provinces in western Canada as well as in the United States of America. The Company, through its operating subsidiaries, ESI Energy Services Inc. ("ESI") and Ozzie's Pipeline Padder, Inc. ("OPI"), supplies (rentals and sales) backfill separation machines ("Padding Machines") to mainline pipeline contractors and utility contractors as well as oilfield pipeline and construction contractors.

There have been no material changes to the Issuer's business and operations within the last month other than the transaction with BMR which was previously disclosed.

Management remains focused on growing the business through internally generated growth opportunities.

Management is in the process of developing a new type of screen made of Polyurethane composite for its Mini-padder and Micro-padding machines.

This transaction was approved by the shareholders at a special meeting of shareholders held on July 03, 2018.

The shares were issued on July 17, 2018.

The Federal Government's decision purchase the Kinder Morgan Trans Mountain Pipeline and the strong possibility that Royal Dutch Shell and its partners will make a decision to proceed with construction of the Prince Rupert LNG Terminal in the latter half of 2018, represent a positive development for the Company's business of renting and selling backfill separation machines ("Padding Machines") to mainline pipeline contractors and owners.
