The La Estrella project continues to progress with ongoing construction of mining camps and underground exploration.

Forge Mining Corp. is a Canadian-listed junior gold exploration company focused on exploring and developing the Alotta project in Canadian Yukon Territory, and holds a controlling interest in Aion Mining Corp., which is developing the La Estrella project, a permitted coal project located in Santander, Colombia.

The Alotta project is a porphyry copper-gold-molybdenum prospect, located 50 km south of the Casino porphyry/epithermal belt. The La Estrella project is fully permitted and contains eight known seams of metallurgical and thermal coal.
