On February 28, 2024, the Issuer announced that its tellurium-based thermoelectric generator was introduced and demonstrated at a presentation in Vancouver on Tuesday, February 27, 2024. The generator was developed by the Issuer's 51%-owned subsidiary, PYRODELTA Energy Inc. (formerly 1406975 B.C. Ltd.).

The generator was presented to the gathering by PYDRODELTA co-founder Michael Abdelmaseh, who showed how the device generated power from simple changes in temperature, producing energy from the heat of human skin as well as from ice. However, the generator's primary advantages come from its robust construction, low manufacturing costs, ability to withstand temperature extremes and light weight.

PYRODELTA's new slogan is "Energy Beyond Sunlight".

The Issuer announced that patents for both manufacturing and intellectual property have now been filed in the United States.

The Issuer's principal assets include:

- an optioned interest in the Colorado Klondike tellurium-gold-silver property located in south-central Colorado under which it may acquire a 100% interest in the property subject to certain royalties.
- a 50% interest in the Deer Horn property located in British Columbia. The Issuer is in receipt of a 5-year exploration work permit from the BC Ministry of Mines and Energy to conduct exploration on its Deer Horn property.
- a 51% equity interest in PYRODELTA Energy Inc., which has developed a prototype for a tellurium-based thermoelectric generator.
- a 49% equity interest in Cheona Metals Inc., with its First Nations partner who holds a 51% equity interest, formed with a mission of restoring placer mines in north western Canada in an environmentally sustainable manner.
