*On a press release dated March 6, 2023, the Issuer announced the results of a petrographic study characterizing the rock types, alteration, and mineralization at the Abriaqui project in Antioquia, Colombia. The Issuer indicated the results showed striking similarities with the formation and characteristics of both the Buritica Mine (Continental Gold/Zijin 11.4 million oz deposit) and the Marmato Mine (Aris Gold, 8.7 million oz deposit).*

*The Issuer also indicated the study consisted of microscopic analysis of samples characterizing all mineralization types throughout the full 1500 vertical meters of known high grade gold mineralization, including the recently discovered Prospera Vein in the Southern Block at Abriaqui (100 continuous meters along strike of 39 g/t gold, 254 g/t silver, 1.2% copper and 2.8% zinc). 36 samples were analyzed to define characteristics of the intrusive rock suite as well as the mineralization history of a deposit.*
