Mr. Schmidt owned 75,600 Common Shares, representing 0.17% of the Company’s 43,288,460 issued and outstanding Common Shares, on an as-converted basis. Under the share exchange agreement, Mr. Schmidt exchanged 75,500 Common Shares for 15,100,000 Class B Subordinate Voting Shares, which are convertible into 75,500 Common Shares, subject to certain conversion limitations set forth in the Company’s articles. Mr. Schmidt’s voting and economic interest in the Company following the Transaction remains at 0.17% of the Company’s issued and outstanding Common Shares, on an as-converted basis. The Transaction is exempt from the issuer bid requirements under applicable securities legislation due to the fact that Mr. Schmidt is a director of the Company, the value of the consideration for the Class B Subordinate Voting Shares acquired is not greater than the market price determined in accordance with applicable legislation and the aggregate number of Common Shares acquired by the Company does not exceed 5% of the outstanding Common Shares.*

PERSONAL INFORMATION COLLECTION POLICY REGARDING FORM 9

The Canadian Securities Exchange and its subsidiaries, affiliates, regulators and agents (collectively, “CSE or the “Exchange”) collect and use the information (which may include personal or other information) which has been provided in Form 9 for the following purposes:

- To determine whether an individual is suitable to be associated with a Listed Issuer;
- To determine whether an issuer is suitable for listing;
- To determine whether allowing an issuer to be listed or allowing an individual to be associated with a Listed Issuer could give rise to investor protection concerns or could bring the Exchange into disrepute;
- To conduct enforcement proceedings;
- To ensure compliance with Exchange Requirements and applicable securities legislation; and
- To fulfil the Exchange’s obligation to regulate its marketplace.

The CSE also collects information, including personal information, from other sources, including but not limited to securities regulatory authorities, law enforcement and self-regulatory authorities, regulation service providers and their subsidiaries, affiliates, regulators and agents. The Exchange may disclose personal information to these entities or otherwise as provided by law and they may use it for their own investigations.

The Exchange may use third parties to process information or provide other administrative services. Any third party will be obliged to adhere to the security and confidentiality provisions set out in this policy.
