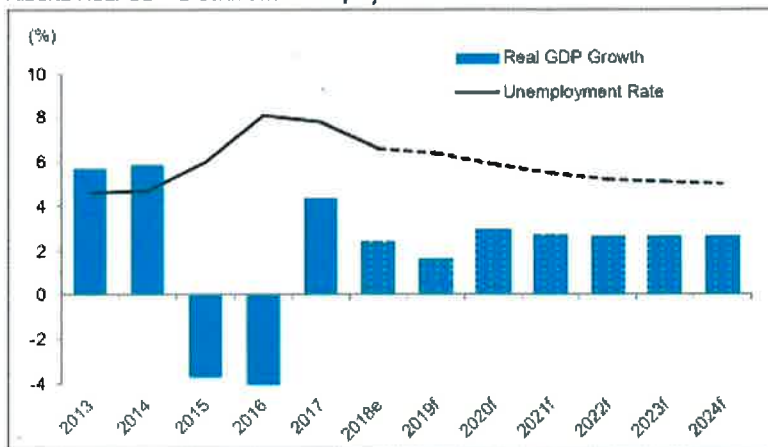

Economic growth is forecast to accelerate in 2020 and remain solid.


