The Issuer is a clinical stage, biopharmaceutical company dedicated to developing treatments for patients suffering from Alzheimer's disease, a devastating neurodegenerative disease, and Cognitive Impairment with mild Traumatic Brain Injury ("mTBI"), a disorder for which there are currently no approved treatment options.

The Issuer continued to work on its principal business objectives as noted below in section 2 during the month of February 2024.

2. Provide a general overview and discussion of the activities of management.

During the month of February 2024, management continued to support the Issuer's business activities and develop the Issuer's business.

During the month of February 2024, management of the Issuer worked to advance its principal business objectives as follows:

- 1) continued to advance its development and commercialization activities for ALPHA-1062 in mild-to-moderate Alzheimer's disease, including program development and clinical manufacturing for ALPHA-1062;
- 2) continued with items discussed at the Investigational New Drug Application ("IND") meeting with the FDA on matters related to the potential IND and related preclinical activities for the research and development program for Cognitive Impairment with mTBI; and
- 3) continued to pursue the out-licensing of its traumatic brain injury ("**TBI**") indication of ALPHA-1062 to a newly formed company which will be seeking funding, where the TBI indication can be further developed.

The Issuer announced that it has filed a new composition-of-matter patent that secures broad protection for its lead asset, ALPHA-1062, currently under review by the FDA for mild-to-moderate Alzheimer's disease.

The present composition-of-matter patent application is filed for approval with the USPTO and may be extended to pursue protection throughout the world and, if approved, will secure composition-of-matter protection for an oral formulation of ALPHA-1062. The filing was based on novel and unexpected findings in the clinical trial work the Issuer completed and further demonstrates the uniqueness of ALPHA-1062. If approved, the patent will provide protection for ALPHA-1062 into 2044, adding to other patent protection that currently protect ALPHA-1062 through 2042.
