Net proceeds from the Offering will be used to fund the Company's working capital needs, including in particular its ongoing litigation in California relating to secured loans made by the Company to CB Holdings in 2018 and 2019, and related litigation in Nevada (the "Litigation").*

*The Company have received \$300,000 in connection with the Offering as at March 31, 2024.*
