The Company is a precious metals royalty and streaming company engaged in the acquisition and management of precious metal royalties, streams and similar production based interests. Non-binding letter of intents were announced in July as follows:

On July 15, 2016 to acquire a specialty streaming and royalty finance company for 10 million shares in Excalibur. The target's current Managing Director is an expert in streaming transactions who has developed an active investment pipeline of 10 potential deals totaling over US\$50 million which is expected to generate US\$15 million in annual cash flow from public and private gold and silver mining companies. As part of the transaction, he will assume the role of President and act as a Director of Excalibur.

On July 20, 2016 to make a \$2.5 million investment in International Explorers and Prospectors Inc. ("IEP"). The investment will be made by way of a 2 year, 5% interest debenture plus warrants representing 19.9% of IEP. Excalibur will issue 10 million 2 year warrants priced at \$0.10 to IEP as part of the proposed transaction.

The company has been looking to finance its pipeline of streaming and royalty investments including a private open pit gold mine in Peru through a debt and equity offering up to US\$10 million. Management is in discussions with several potential lenders and investors.
