The Issuer is a clinical stage, biopharmaceutical company dedicated to developing treatments for patients suffering from Alzheimer’s disease, a devastating neurodegenerative disease, and Cognitive Impairment with mild Traumatic Brain Injury (“**mTBI**”), a disorder for which there are currently no approved treatment options.

The Issuer continued to work on its principal business objectives as noted below in section 2 during the month of March 2024.

During the month of March 2024, management continued to support the Issuer's business activities and develop the Issuer's business.

During the month of March 2024, management of the Issuer worked to advance its principal business objectives as follows:

- 1) continued to advance its development and commercialization activities for ALPHA-1062 in mild-to-moderate Alzheimer's disease, including program development and clinical manufacturing for ALPHA-1062;
- 2) continued with items discussed at the Investigational New Drug Application ("IND") meeting with the FDA on matters related to the potential IND and related preclinical activities for the research and development program for Cognitive Impairment with mTBI; and
- 3) continued to pursue the out-licensing of its traumatic brain injury ("TBI") indication of ALPHA-1062 to a newly formed company which will be seeking funding, where the TBI indication can be further developed.
