On March 14, 2024, the Issuer announced its financial results for the fourth quarter and full year ended December 31, 2023.¹

In Pennsylvania, there are 180 operational dispensaries and 33 operational grower/processors as of March 1st.²

On March 28th, Governor Youngkin vetoed a bill to establish a legal market for the sale of adult-use cannabis in Virginia.³

In Virginia, there are 22 operational dispensaries in the Commonwealth as of March.⁴

In Nevada, the State of Nevada's Cannabis Compliance Board has issued and outstanding 798 medical and recreational operational licenses/certificates issued statewide as of March.⁵

In Massachusetts, the Commonwealth's Cannabis Control Commission reported 605 adult-use and 102 medical use cannabis licenses are issued and outstanding as of March,⁶ and adult-use and medical sales during the month of March as of March 17, 2024, was \$76.5M and \$9.6M, respectively.⁷
