The Company is a junior mining company focused on generating precious metal cash flows from diverse mining operations and has developed a US\$50 million pipeline of potential gold and silver streaming and royalty investments.

The Company has been seeking financing for a private Peruvian operating gold mine and a non-binding gold stream proposal was accepted and announced on March 7, 2016. The Company announced the closing of a \$200,000 common share financing on May 9, 2016 – see PR :

The company continues to seek potential investments in the healthcare sector, with a focus on medical tourism in Mexico.

The company has been looking to finance its pipeline of streaming and royalty investments via a debt offering up to US\$10 million including for a private operating open pit gold mine in Peru via the purchase of a gold stream. This mine produced 2900 ounces of gold in January, 3600 ounces in February, 4000 ounces per month in March and April and forecasts 5000 ounces in May/June. Management has identified two other investment transactions ready for execution, subject to financing and is in discussions with several potential lenders and investors.
