On June 4, 2020, the Issuer announced that it would be unable to file its annual audited consolidated financial statements for the financial year ended December 31, 2019, the related annual management's discussion and analysis and the related CEO and CFO certifications (collectively, the "2019 Financial Disclosure") by June 13, 2020 in accordance with the

requirements of National Instrument 51-102 – *Continuous Disclosure Obligations* and National Instrument 52-109 – *Certification of Disclosure in Issuer’s Annual and Interim Filings*. The Issuer relied on relief provided by Ontario Instrument 51-502-*Temporary Exemption from Certain Corporate Finance Requirements* (and similar exemptions provided by the securities commissions of British Columbia and Alberta) in connection with the late filing of its 2019 Financial Disclosure. The delay was due to a dispute with the former owners/managers of one of the Issuer’s acquisitions completed during the year ended December 31, 2019, who have stopped assisting the issuer in providing its auditors with certain audit support.

On June 19, 2020, the Issuer announced that the Ontario Securities Commission granted the issuer’s request for a management cease trader order (the “MCTO”), which was made by the Issuer in connection with the anticipated delay in the filing of its 2019 Financial Disclosure. The MCTO restricted the Issuer’s CEO and CFO from trading in any securities of the Issuer while the MCTO was in effect. The Issuer also imposed a trading blackout on its directors and officers pending filing of the 2019 Financial Disclosure.

On June 30, 2020, the Issuer filed its 2019 Financial Disclosure.

The Issuer was focused on developing new products, expanding its brand through new licensees and seeking strategic opportunities.
