Report on Business

In January the Issuer announced the results of a drilling program that it undertook in the autumn of 2017.

In February the company utilized an underwater remote operated vehicle to inspect the condition of the mine shaft and timberwork of the New Brunswick Shaft to a depth of 232 m where it entered the B580 Level shaft station. The flooded New Brunswick Shaft is located very close to the recent drill intercept of the Brunswick #1 Vein, the results of which were announced by the Issuer in a press release on January 3, 2018, and would be potentially useful to the I-M Mine project in the future. The existing mine shaft and timberwork appear to be in good condition with a low probability of rot due to low oxygen levels in the water. Using a weight and cable, the Issuer also found that the shaft remains open at least to a depth of 701 m.

Notably, the drill results announced in the Issuer's press release dated January 3, 2018 showed high-grade gold in andesite wall rock adjacent to the quartz vein that has historically been the

target of miners in the I-M Mine. In February the Issuer researched documents stored at Sacramento State University related to the I-M Mine which showed that historic miners commonly left non-quartz wall rock unmined or as backfill and only removed the quartz vein rock for processing. Management of the Issuer has determined that the presence of significant gold in vein walls may have an important positive impact to the exploration targets as historic drilling would have greatly underreported the overall gold content of the mineralized structures tested.
