A proposed share for share exchange agreement was entered into between Cannara Biotech Inc. and Global shopCBD.com Inc., for which the Company will acquire all of the issued and outstanding shares of Global shopCBD.com Inc. that it currently does not own. The Company currently owns 61.23% of the outstanding common shares of Global shopCBD.com Inc.
