The Company continues to hold an 18.5% interest in Rockshield Engineered Wood Products ULC ("REWP") and this investment is no longer a core holding. The Company has been advised that REWP operations remain at breakeven point and REWP may be conducting additional financings. The Company has advised REWP that it does not plan to participate in any REWP financing.

The Company has built up a strong cash position with over \$3.5 million in cash reserves generated from the liquidation of certain holdings in the cannabis and medical devices sector. The Company continues to monitor opportunities to liquidate certain holdings but current market is not strong. All of the Company's holdings are currently trading in range of year low levels. The Company's

entry position was ground floor level so fortunately the Company is not out on its cash investment. The Company continues to investigate investment opportunities and consider opportunities to maximize values for shareholders.

Management continued to review investment opportunities and monitor its portfolio holdings.
