The Issuer formed a strategic alliance with Deloitte Canada LLP ("Deloitte") to deliver blockchain product-traceability solutions to the cannabis industry.

Aphria Inc. and Tilray Canada Ltd., a subsidiary of Tilray, Inc. joined Phase 2 of the blockchain-secured pilot program (the "Pilot Program") with Shoppers Drug Mart. Phase 2 of the Pilot Program, using Deloitte's project management and advisory capacity and the Issuer's StrainSecure™ system, will be focused on developing a unified approach to medical cannabis standards, onboarding licenced producers and other partners to track and trace all product history—from genome to distribution. The program is expected to help researchers and clinicians to match therapeutic outcomes to specific genetic and chemical profiles, and provide physicians, pharmacists, and patients with greater confidence in the products they prescribe or consume.

The Issuer closed a second tranche (the "Second Tranche") of a non-brokered private placement financing (the "Financing"). The Second Tranche consisted of 840,950 units (each, a "Unit") of the Company at a price of \$0.25 per Unit for gross proceeds of \$210,237.50. Each Unit consists of one common share and one non-transferable common share purchase warrant (each, a "Warrant"). Each Warrant entitles the holder to purchase one additional common share at a price of \$0.30 per common share for a period of three (3) years from the closing of the Financing. The Company issued 26,400 Shares and 26,400 Warrants to certain finders in connection with the closing of the Second Tranche.
