CLAIMING DAMAGES FOR ALLEGED BREACH OF A MANAGEMENT SERVICES CONTRACT DATED MARCH 12, 2018 AND FOR RETURN OF INVESTMENTS MADE IN THE COMPANY. THE COMPANY DENIES THE ALLEGATIONS AND INTENDS TO VIGOROUSLY DEFEND THE ACTION AND PURSUE ITS COUNTERCLAIM. THE PROCESS OF EXAMINATION FOR DISCOVERY CONTINUED IN THIS SCURRILOUS PUBLICITY SEEKING LAWSUIT.

BELGRAVIA ALSO COMPOUNDED ITS DEFAMATORY STATEMENTS BY PUBLICLY ALLEGING THAT THE COMPANY WAS INSOLVENT, A LIBEL CLEARLY CONTRADICTED BY THE FACTS WHICH WILL SUBSTANTIALLY ENHANCE THE COMPANY'S CLAIMS IN THE LAWSUIT.
