The Company commenced a focused drilling program at Yeungroon. The drilling program consists of four planned holes designed to test the high-grade gold potential along strike and below the historic Golden Jacket mine. The Company provided an update on the drilling progress on October 26, 2021. Please see news release for further details.

The final results from the drill holes at Glenfine were announced on October 26, 2021 as well. Please see news release for further details.

The Company will be holding its annual general meeting on November 30, 2021. The record date for the meeting was October 26, 2021 and shareholders can expect to receive the materials in the coming weeks.

Due to COVID-19, the State of Victoria, Australia, has implemented various lockdowns with several restrictions over the last few months including travel restrictions. Currently, anyone that wants to enter the State of Victoria, must not be coming from an extreme risk zone, as classified by Australia, and must have a travel permit.

The Company's business travel has been very restricted and various business operations including permitting processes and exploration mobilization have seen delays. The Company and its wholly owned subsidiary, Outback Goldfields Australia, puts the safety of our contractors and employees first. Measures, such as working from home and enhanced safety precautions have been put in place. Exploration work continues in a modified way as mining is considered an essential service by the Victorian government. However, there has still been delays in assay results, drilling, sampling and gaining landholder access.

The Issuer is involved in the acquisition and exploration of mineral property assets.

The Company currently has the four gold exploration properties located in the Victorian Goldfields of Australia; Glenfine Property, Yeungroon Property, Silver Spoon Property and the Ballarat West Property.

The Company also has two gold exploration properties located in British Columbia; the Gossan Property and the SBS Property .

The Company has a wholly owned subsidiary in Australia, Outback Goldfields Australia Pty Ltd.
