The Issuer engaged Canaccord Genuity Corp., on behalf of a syndicate of agents, in connection with a private placement offering, on a "commercially reasonable efforts" basis, of up to 16,666,667 units of the Company (the "Units") at a price of C\$0.30 per Unit, with each Unit consisting of one common share and one common share purchase warrant, with each warrant entitling the holder to purchase one common share for a period of two years from the closing date of the offering at an exercise price of \$0.45 per common share. Canaccord Genuity Corp. is not a Related Person of the Issuer.
