The Issuer has outstanding current liabilities for settlement of a loan by the CEO of \$9,679. As at March 31, 2020 interest was owed in the amount of \$272. A total of 3,400 common shares are being issued at a price of \$0.08 per common shares. The CEO has gifted a portion of his shares.

The Issuer has outstanding current liabilities for settlement of a loan by the President of \$10,000. As at March 31, 2020 interest was owed in the amount of \$297. A total of 3,713 common shares are being issued at a price of \$0.08 per common shares.

The Issuer has outstanding current liabilities for settlement of compensation to its current CEO and President. The Issuer will Issue 156,875 to the President and 156,875 to the CEO all at \$0.08/share. The CEO has gifted a portion of his shares.

The Issuer has a contract with Sophic Capital. The Issuer currently has outstanding liabilities of \$7,910 and is issuing 87,889 common shares at \$0.09 to settle the debt.

On June 24, 2019, the Issuer issued to Merida Capital Partners II LP an amended Promissory Note. Pursuant to the Note, interest is payable at the rate of 12% per annum payable quarterly in Issuer shares at a price equal to the 30-day VWAP with 18% discount. The Issuer will issue 1,213,443 common shares at a price of \$0.069 per common share as part of its interest payment on this debt note.

Common Shares are being issued to the CEO and President – see paragraph 3 above for details.

On January 27, 2020 the Issuer entered into an agreement with Ariza Holding Inc. The Issuer has outstanding liabilities of \$30,000 and is issuing 422,535 common shares at \$0.071 per common share to settle the debt.

The Issuer announced that it entered into an Asset Purchase Agreement dated April 3, 2019 (the "Agreement") with Rae of Sunshine Health Services ("ROSH"). Pursuant to the Agreement, and upon the completion of certain milestones that were to be completed 12 months from the closing date, the Issuer must issue to the Seller common shares valued up to US \$100,000 based upon the 30-day VWAP of Issuers shares. The Issuers 30-day VWAP is C\$0.085 so a total of 882,978 shares are to be issued.

All issuances of Issuer shares will be subject to a minimum hold period of four (4) months plus one (1) day from the date of issuance.
