The Issuer has entered into an agreement to acquire 100% of the interest of Yellow Rock Uranium Corp. in various mineral claims located 15 km northwest of Uranium City in the Beaverlodge Uranium District and is comprised of 120 claims spanning 1,978 ha over the Chariot River.

The Issuer entered into an Option Agreement dated February 23, 2024 with Yellow Rock Uranium Corp. (the "Agreement") pursuant to which the Issuer will acquire from Yellow Rock Uranium Corp. ("Yellow Rock") a 100% ownership interest in the mineral claims located 15 km northwest of Uranium City in the Beaverlodge Uranium District. The interest is comprised of 120 claims spanning 1,978 ha over the Chariot River. Yellow Rock will retain a 2% NSR. The Issuer may purchase a 1% NSR at any time for \$1,000,000.

Pursuant to the terms of the Agreement and in order to complete the transaction, the Issuer shall pay to Yellow Rock:

- a) An initial 40% interest for \$50,000 and issuance of 3 million shares;
- b) An additional 10% interest for a total of 50% on completion of exploration expenditures during the first year of \$100,000;
- c) An additional 25% interest for a total of 75% on completion of \$150,000 in exploration expenditures during the second anniversary of \$150,000 and issuance of 2 million shares;
- d) An additional 25% interest for a total of 100% completion of \$300,000 in exploration expenditures during the third anniversary and issuance of 2 million shares.
