The Issuer has entered into an agreement to acquire 100% of the interest of Yellow Rock Uranium Corp. in various mineral claims located 15 km northwest of Uranium City in the Beaverlodge Uranium District and is comprised of 120 claims spanning 1,978 ha over the Chariot River.

The Issuer entered into an Option Agreement dated February 23, 2024 with Yellow Rock Uranium Corp. (the "Agreement") pursuant to which the Issuer will acquire from Yellow Rock Uranium Corp. ("Yellow Rock") a 100% ownership interest in the mineral claims located 15 km northwest of Uranium City in the Beaverlodge Uranium District. The interest is comprised of 120 claims spanning 1,978 ha over the Chariot River. Yellow Rock will retain a 2% NSR. The Issuer may purchase a 1% NSR at any time for \$1,000,000.

Pursuant to the terms of the Agreement and in order to complete the transaction, the Issuer shall pay to Yellow Rock:

- a) **An initial 40% interest for \$50,000 and issuance of 3 million shares;**
- b) **An additional 10% interest for a total of 50% on completion of exploration expenditures during the first year of \$100,000;**
- c) **An additional 25% interest for a total of 75% on completion of \$150,000 in exploration expenditures during the second anniversary of \$150,000 and issuance of 2 million shares;**
- d) **An additional 25% interest for a total of 100% completion of \$300,000 in exploration expenditures during the third anniversary and issuance of 2 million shares.**

Appendix A

PERSONAL INFORMATION COLLECTION POLICY REGARDING FORM 9

The Canadian Securities Exchange and its subsidiaries, affiliates, regulators and agents (collectively, “CSE or the “Exchange”) collect and use the information (which may include personal or other information) which has been provided in Form 9 for the following purposes:

- To determine whether an individual is suitable to be associated with a Listed Issuer;
- To determine whether an issuer is suitable for listing;
- To determine whether allowing an issuer to be listed or allowing an individual to be associated with a Listed Issuer could give rise to investor protection concerns or could bring the Exchange into disrepute;
- To conduct enforcement proceedings;
- To ensure compliance with Exchange Requirements and applicable securities legislation; and
- To fulfil the Exchange’s obligation to regulate its marketplace.

The CSE also collects information, including personal information, from other sources, including but not limited to securities regulatory authorities, law enforcement and self-regulatory authorities, regulation service providers and their subsidiaries, affiliates, regulators and agents.
