(“WEM”) from the shareholders of WEM in consideration for the issuance of 4,250,000 common shares of the Issuer at a deemed price of \$0.21 per common share. WEM owns a 100 per cent undivided, unencumbered legal and beneficial interest in both the Blackie and the Penece Vanadium properties (the “Properties”), located in northwestern British Columbia. The Properties cover a total area of 2713.63 hectares and host vanadium mineralization within large bodies of titaniferous magnetite. Both properties are strategically located on tidewater, near to the small coastal cities of Port Hardy (Penece – 68km) and Prince Rupert (Blackie – 96km).
