The Dome Mountain Project, located near the town of Smithers in northwest British Columbia, is held through the Company's subsidiary, Gavin Mines Inc. ("Gavin Mines"). The Issuer held 78.27% of the shares of Gavin Mines and the remaining 21.73% were held by three arm's length parties. The Issuer entered into a share purchase agreement (the "Agreement") with Troy Walker, Paula Walker, and Walker's Trade International Inc. (collectively the "Sellers") dated July 9, 2021, pursuant to which the Issuer agreed to purchase a total of 99,859 common shares in the capital of Gavin Mines from the Sellers in consideration for 400,000 common shares of the Company at a deemed price of \$0.73 per share.

The Issuer now owns 100% of the Dome Mountain gold project.

PERSONAL INFORMATION COLLECTION POLICY REGARDING FORM 9
