On May 11, 2018, Idaho Champion Cobalt USA, Inc. ("Champion Cobalt") was incorporated as a wholly-owned Idaho corporation. This subsidiary was incorporated to acquire cobalt assets pursuant to a purchase and sale agreement with American Cobalt Corp. American Cobalt Corp. earned 4,000,000 common shares with mining claims transferred to Champion Cobalt. The Company completed the purchase of 822 federal US mining claims in four blocks (approximately 6,871 hectares) in Lemhi County, Idaho from American Cobalt Corp. in the Idaho Cobalt Belt, collectively known as the "Champion Projects." Champion received notice from American Cobalt and the Bureau of Land Management (BLM) that the claims have been registered to Idaho Champion Cobalt. As compensation for the Champion Projects, the Company issued 4,000,000 common shares of the Company. Idaho Champion Cobalt USA now owns 822 claims, a total of approximately 6,871 Hectares.
