The disclosure should be sufficiently complete to enable a reader to appreciate the significance of the transaction without reference to any other material: The Issuer proposes to acquire a 60% interest in certain mineral tenures (the “Project”) located in the Abitibi region of northwestern Quebec, proximal and to the east of the town of Normétal. The Project is comprised of 169 mineral claims covering approximately 8,148 hectares of prospective Archean stratigraphy of felsic through to mafic volcanic rocks, sediments, and numerous intrusions of varying age and compositions. The Project has been explored sporadically over the years following the discovery and mining of the Normétal polymetallic mine, which was discovered in 1929 and mined until 1975, reaching a depth of 2,400 metres below surface.

2. Provide details of the acquisition including the date, parties to and type of agreement (eg: sale, option, license etc.) and relationship to the Issuer. The disclosure should be sufficiently complete to enable a reader to appreciate the significance of the acquisition without reference to any other material: The Issuer entered into an arm’s length purchase agreement dated July 7, 2020 (the “Purchase Agreement”) with 2420-2970 Quebec Inc. (“Belanger”) and Pierre Gervais (“Gervais”) (Belanger and Gervais together, the “Vendors”), whereby the Company has agreed to purchase from the Vendors, and the Vendors have agreed to sell to the Company, a 60% interest in certain mineral tenures located in the Province of Quebec, Canada known as the Gervais-Belanger property (the “Gervais-Belanger Property”) in consideration of: (i) total cash consideration of \$300,000 payable by the Company to the Vendors, in tranches; (ii) the issuance of an aggregate of 4,500,000 common shares (the “Consideration Shares”) in the capital of the Company to the Vendors, issuable in tranches; (iii) granting in favour of the Vendors a 3% net smelter returns royalty (the “Royalty”), with no buy-back provision (of the 3% Royalty, 1.8% of the Royalty shall be granted in favour of Belanger and the remaining 1.2% of the Royalty shall be granted in favour of Gervais or as otherwise directed by the Vendors).

PERSONAL INFORMATION COLLECTION POLICY REGARDING FORM 9
