Preparation for the 2020 cultivation continues at the farm. The team at Scio is taking all necessary precautions required due to the COVID-19 virus to be safe on the farm. Fortunately, the farm is large enough in size that the team can be widely spread out throughout the property while carrying out their daily duties to ready the farm for planting.

While some sales had been completed on the 2019 biomass, others that had been lined up and were in the process of being executed have been delayed due to current virus conditions but are continuing to be pursued where possible. The team also continues to look into a number of value-added products that can be produced and marketed utilizing the Company's biomass and oils, thereby maximizing the value that the Company can receive for its inventory. In addition, the team is working on several additional initiatives that will generate further revenue for CBA in addition to cultivation related activities.

Greenhouse Operations

In addition to the CBD genetics being grown, the Scio team has also acquired high CBG genetics that will be used for the 2020 cultivation. Cloning activities continue to be ready for planting.
