The disclosure should be sufficiently complete to enable a reader to appreciate the significance of the transaction without reference to any other material: Pursuant to the Option Agreement for the Las Tinajas Gold Project, Chile, the Issuer entered into a Settlement Agreement with Horizonte Mining SpA (“Horizonte”), an arm’s length party to the Issuer, in respect of matters that arose with Las Tinajas and information that Horizonte provided to the Issuer under the terms and conditions of a non-disclosure agreement between the Issuer and Horizonte dated November 13, 2025. Horizonte is also arm’s length to the property vendors, Sociedad Contractual Minera Las Tinajas and Compañía de Inversiones Mineras S.A. The Settlement Agreement settles matters between the Issuer and Horizonte and provides commercial certainty to the Issuer in respect of its earn-in under the Option Agreement.

PERSONAL INFORMATION COLLECTION POLICY REGARDING FORM 9
