During the month of November 2020, management of the Issuer continued with existing operational oversight, corporate governance and general operations.

Due to the COVID-19 pandemic, the Issuer is maintaining a minimal operating staff at its licensed Delta facility. The province of British Columbia has classified cannabis cultivation as an essential service. The Issuer is making every effort to maintain full operation in this difficult time.

On November 27, 2020, the Issuer completed and filed its financial statements and accompanying management's discussion and analysis for the six months ended September 30, 2020.

On December 3, 2020, the Issuer announced that it has changed its name from Vodis Pharmaceuticals Inc. to Gnomestar Craft Inc. and its ticker symbol from "VP" to "GNOM". Subject to approval of the Canadian Securities Exchange (the "CSE"), the Issuer expected the name and symbol change to take effect on December 7, 2020 when its common shares will begin trading on the CSE under the new name "Gnomestar Craft Inc." and new ticker symbol "STAR".

Management of the Company focused significant efforts on sourcing operating capital to support the working capital of the Company.
