On July 30, 2021, the Issuer announced it had entered into an earn-in agreements (“Underlying Agreements”) which the Issuer may earn a 100% interest in the 8,175 hectare Pat’s Pond and 13,145.5 hectare O’Neill projects located in the Central Newfoundland Gold Belt, central Newfoundland.

For the option to earn 100% of the Pat’s Pond and O’Neill claims, the Issuer must issue 2,600,000 common shares on or before 5 business days after the effective date.

For Pat’s Pond, the Issuer shall issue a further 1,200,000 shares on the first anniversary of the effective date and then 800,000 on the second anniversary date of the effective date. The vendors retain a 2% NSR royalty (with the right to re-purchase on-half of the NSR at any time by payment to the beneficial owner of \$1,000,000).

For the option to earn a 100% interest in the O’Neill property, the Issuer must issue 1,400,000 common shares on the effective date.

The interest in the Underlying Agreements were assigned to the Issuer in consideration of the issuance of 4,500,000 common shares (“Assignment Shares”) pursuant to the assignment agreements.

PERSONAL INFORMATION COLLECTION POLICY REGARDING FORM 9

The Canadian Securities Exchange and its subsidiaries, affiliates, regulators and agents (collectively, “CSE or the “Exchange”) collect and use the information (which may include personal or other information) which has been provided in Form 9 for the following purposes:
