

CORE SAMPLING COMPLETED AT L.A.B. GRAPHITE PROJECT

Vancouver, B.C. (May 14, 2018) – Graphite Energy Corp. (CSE: GRE, OTCPink: GRXXF, FWB: G0A) (the "Company) is providing an update to exploration developments at the L.A.B. (Lac Aux Bouleaux) Graphite Project located near the town of Mont-Laurier, Quebec. The Company has chosen to contract InnovExplo of Val d'Or, Quebec, to provide technical assistance and guidance for the re-evaluation of drill core, and the further exploration of the project.

InnovExplo has provided on site, independent technical assistance for the completion of core cutting, core logging and sampling. Supervision at the project site is being provided by Lindsay Richan, P.Geo, M.Sc, a registered geologist in the Province of Quebec, and a Qualified Person as defined under National Instrument 43-101. As per NI 43-101 Exploration Best Practices Guidelines, procedures set in place by the Qualified Person regarding sample collection, preparation and security have been followed. Core from all four holes has been cut, samples bagged and prepared for shipment to ALS Geochemistry laboratory of Val d'Or Quebec, a certified laboratory for analysis. Upon receipt of results, InnovExplo will provide further recommendations.
