Proceeds from the Offering are expected to be used for legal and other costs associated with closing the previously announced acquisition of Eleusian Biosciences Corp., marketing expenses and for general working capital purposes. Pursuant to this debt settlement agreement, a total of \$20,000 of debt will be settled through the issuance of 400,000 common shares at a deemed price of \$0.05 per share.

On July 15, 2020, the Company entered into debt settlement agreements with RCF Advisors Ltd. ("RCF") and SENTA Capital Inc. ("SENTA"), in settlement of amounts owing in respect of services provided to the Company by RCF and SENTA through July 30, 2020. Pursuant to the debt settlement agreements, a total of \$55,000 of debt will be settled through the issuance of 100,000 common shares to RCF and 1,000,000 common shares to SENTA, at a deemed price of \$0.05 per share

PERSONAL INFORMATION COLLECTION POLICY REGARDING FORM 9

The Canadian Securities Exchange and its subsidiaries, affiliates, regulators and agents (collectively, “CSE or the “Exchange”) collect and use the information (which may include personal or other information) which has been provided in Form 9 for the following purposes:

- To determine whether an individual is suitable to be associated with a Listed Issuer;

- To determine whether allowing an issuer to be listed or allowing an individual to be associated with a Listed Issuer could give rise to investor protection concerns or could bring the Exchange into disrepute;
- To conduct enforcement proceedings;
- To ensure compliance with Exchange Requirements and applicable securities legislation; and
- To fulfil the Exchange’s obligation to regulate its marketplace.

The CSE also collects information, including personal information, from other sources, including but not limited to securities regulatory authorities, law enforcement and self-regulatory authorities, regulation service providers and their subsidiaries, affiliates, regulators and agents. The Exchange may disclose personal information to these entities or otherwise as provided by law and they may use it for their own investigations.
