## GREEN 2 BLUE CLOSES OVER-SUBSCRIBED PRIVATE PLACEMENT

**Vancouver, British Columbia – April 17, 2018** - Green 2 Blue Energy Corp. (CSE: GTBE, OTCQB: GTGEF, FWB: 1NZ.F) ("**G2BE**" or the "**Company**") announces that, further to its news release dated April 12, 2018, it has closed an over-subscribed non-brokered private placement financing of units (the "**Units**") for gross proceeds of \$4,280,000 (the "**Offering**").

Pursuant to the Offering, the Company issued 14,266,665 Units at a price of \$0.30 per Unit. Each Unit consisted of one common share in the capital of the Company (a "**Share**") and one common share purchase warrant (a "**Warrant**"), whereby each Warrant entitles the holder thereof to purchase one additional Share (a "**Warrant Share**") at a price of \$0.35 per Warrant Share for a period of 18 months from the date of issuance. The proceeds received from the Offering will be used to complete facility upgrades, equipment purchases and for general working capital of the Company.

G2BE is a renewable energy company focused on residential and commercial wood pellet production and the implementation of biomass gasification technology to generate combined heat and power. G2BE's wood pellets are sold to retail outlets and power producers throughout Europe, including the United Kingdom, Germany, Poland, Italy and Denmark.
