GeneTether Therapeutics Inc. is focused on developing its disruptive proprietary platform technology to significantly increase the efficiency of DNA insertion into the genome for gene correction and complementation strategies. The Issuer's wholly-owned platform technology uses a

proprietary method to "tether" donor DNA templates to the genome editing complex, making the template readily available for use during the genome editing repair stage. The Issuer is leveraging its platform technology to develop curative therapies for the treatment of rare genetic diseases. The Issuer's proof of concept study demonstrated an approximately 7x higher gene editing efficiency as compared to the same gene editing payload without application of the Issuer's technology.
