In a press release dated September 10, 2021, the Issuer announced that it extended the expiry date of an aggregate of 2,236,985 previously issued subordinate voting share purchase warrants (the "SVS Warrants") and 4,183 previously issued series A multiple voting share purchase warrants (the "MVS Warrants" and, together with the SVS Warrants, the "Warrants") exercisable at a price of CDN\$0.30 per SVS Warrant and CDN\$30.00 per MVS Warrant, to March 28, 2022. The extension was effected in accordance with the terms of the certificates evidencing the Warrants and the policies of the Canadian Securities Exchange. The extension is effective September 13, 2021 and the Warrants had previous expiry dates ranging from September 28, 2021 to October 15, 2021.
