Indus Holding Company, a Delaware corporation and wholly owned subsidiary of Issuer, will acquire 70% of the issued and outstanding limited liability company interests of Shredibles, LLC, a Nevada limited liability company in the business of developing, manufacturing and distributing CBD protein bars.

(a) On June 12, 2019, each of (i) Indus Holdings, Inc., a British Columbia corporation ("Issuer"), (ii) Indus Holding Company, a Delaware corporation and wholly owned subsidiary of Issuer ("Buyer"), (iii) Shredibles LLC, a Nevada limited liability company (the "Company"), (iv) Rodman Hanson ("Hanson") and (v) Matthew Callans ("Callans" and, together with Hanson, "Sellers") entered into a Membership Interest Purchase Agreement (the "Purchase Agreement"), pursuant to which Buyer purchased from Sellers 70% of the issued and outstanding limited liability company interests of the Company in exchange for 42,550 subordinate voting shares of Issuer.

(b) Concurrent with such closing, on June 12, 2019: (i) Buyer also entered into an Amended and Restated Operating Agreement of the Company, pursuant to which Buyer is committed to provide US\$1,000,000 in capital contributions to the Company within two years of the closing (of which US\$50,000 will be used to pay off the US\$50,000 Amended Promissory Note issued to the Company as borrower), to be provided in such amounts as needed as determined by the board of directors of the Company, with any remaining balance up to US\$1,000,000 to be contributed by Buyer within ten days after the second anniversary of the closing and distributed to the members of the Company pro rata in accordance with their interests; and (ii) an affiliate of Buyer entered into an employment offer letter with Hanson and an employment offer letter with Callans, pursuant to which each is entitled to (A) a US\$85,000 annual salary, (B) a US\$50,000 signing bonus, (C) a US\$100,000 milestone bonus if the Company's annual revenue reaches US\$5,000,000, (D) a US\$200,000 milestone bonus if the Company's annual revenue reaches US\$10,000,000 and (E) a 25,000 share Issuer option grant vesting over four years.
