The conversion is effected under the terms of a separate interest settlement and share issuance agreement (or amendment, if applicable), which provides that the accrued interest is forgiven in exchange for the issuance of shares at an agreed valuation.

No portion of the principal indebtedness is being forgiven or converted as part of this transaction.

The accrued interest subject to conversion totals \$71,784.33, calculated in accordance with the terms of the original debt agreement. Upon issuance of the securities, this accrued interest obligation is considered fully satisfied.
