  - b) ***On January 10, 2019, the Company announced that it intends to enter into a non-brokered private placement financing whereby the Company may raise gross proceeds of up to \$2,500,000 by issuing up to 10,000,000 units of the securities of the Company at the price of \$0.25 per unit (the "Proposed Financing"). Each Unit will consist of one common share in the capital of the Company and one share purchase warrant to purchase an additional common share in the capital of the Company at the price of \$0.50 per common share for a period of 18 months from the Closing of the Proposed Financing. Finder's fees may be payable in respect to this proposed transaction and certain insiders may participate in this Proposed Financing. All securities that will be issued in connection with this Proposed Financing will include a hold period in accordance with applicable securities laws. In the event that 37 Capital shares trade at \$0.75 per share or above for a period of 15 consecutive days, a forced exercise provision will come into effect for the warrants issued in connection with the Proposed Financing.***
