The principal business of the Company is the identification, acquisition, exploration and, if warranted, the development of natural resource properties.

 - a) ***Management is currently pursuing the possibilities of acquiring opportunities of merit for the Company, and is actively pursuing the possibilities of raising funds for the Company.***
 - b) ***During the Company's 2020 fiscal year, the Company intended to issue up to 4,000,000 flow-through units of the Company at a price of \$0.05 per unit for gross proceeds to the Company of \$200,000 in order to use the proceeds of this financing towards exploration work expenditures on the Acacia Property, which is located in the Province of British Columbia (the "Acacia Property"). However as of the date of this Monthly Progress Report, the Company has only been able to raise the amount of \$20,000 which the Company intends to incur towards exploration work expenditures on the Acacia Property during the Company's 2021 fiscal year.***
 - c) ***On January 15, 2021, the Company announced that it has entered into debt settlement agreements with certain creditors (the "Company's Creditors") whereby the Company's Creditors have agreed to accept common shares in the capital of the Company as full and final settlement of amounts owing to the Company's Creditors. Pursuant to the debt settlement agreements, the Company may issue to the Company's Creditors up to 23,328,810 common shares in the capital of the Company at a deemed price of \$0.05 per share. On January 25, 2021, the Company issued 14,787,030 common shares of the Company (the "Debt Settlement") at a deemed price of \$0.05 per common share to certain creditors, including to a related party and a director and officer of the Company (the "Creditors"). The securities issued are subject to a hold period which expires on May 26, 2021.***

iii. **Governmental regulations, including those regulations governing the protection of the environment, taxes, labour standards, occupational health, waste disposal, mine safety and other matters, could have an adverse impact on the Issuer.**
