**The Issuer completed its initial public offering on August 29, 2019 and commenced trading on the Canadian Securities Exchange on August 30, 2019 under the symbol "VC".**

**The Issuer is engaged in the business of mineral exploration and the acquisition of mineral property assets in Canada. Its objective is to locate and develop economic precious and base metal properties of merit, and to conduct its exploration program on the Sunset Copper Star Property (the "Sunset Copper Star Property"). The Sunset Copper Star Property consists of two (2) mineral titles covering an area of 1,138.15 hectares, located approximately 19 kilometres northwest of the city of Campbell River, British Columbia, Canada.**

The Issuer competes with other companies with greater financial resources and technical facilities. The Issuer may be affected by political, economic, environmental and regulatory risks beyond its control. The Issuer is currently largely dependent on the performance of its directors and officers and there is no assurance the Issuer can retain their services. In recent years both metal prices and publicly traded securities prices have fluctuated widely.**
