Global Wellness Strategies valuation for tranche issuances will be subject to a 30 day VWAP with a base share price set at \$0.20 There is an additional contingent consideration of CDN\$2,500,000 to Shanti based on the performance of their assets and specific milestones must be met. Shanti shall have the right to appoint one director to the board of Global Wellness Strategies Inc.
