Miramont (CSE: MONT) (OTCQB: MRRMF) (FRANKFURT: 6MR) is a Canadian based exploration company with a focus on acquiring and developing mineral projects within prospective belts of South America. Miramont's key assets are located in southern Peru, held by Minera Puno Gold, S.A.C. ("Minera Puno"), a Peruvian subsidiary of Miramont's wholly owned subsidiary, Puno Gold Corporation ("Puno"). The Cerro Hermoso property hosts a 1.4km diameter breccia pipe

targeting gold - polymetallic mineralization; the Milenos 32 concession, adjacent to the Cerro Hermoso project which gives Miramont full control of the Pocomoro zone, is where highly anomalous copper and silver has been identified in surface rock samples; the An An concession borders the Cerro Hermoso concession block on its southeast boundary; and the Lukkacha property targets porphyry copper mineralization. Miramont is currently focusing its resources on the Cerro Hermoso and Lukkacha properties.

The Issuer announced that it commenced phase 2 diamond drilling at its Cerro Hermoso property to follow up on mineralization encountered in the Central Breccia Zone.
