On February 12, 2024, a notice of civil claim was filed against the Company for an alleged breach of contract. In February 2021, we issued a convertible note for \$650,000. While \$500,000 converted to shares, \$150,000 remained outstanding with a due date of August 2022. The plaintiff demanded full repayment in December 2023 and claims we breached the agreement by not repaying. We are currently defending ourselves in the BC Supreme Court after responding to the lawsuit on March 7, 2024
