Our commercial product, BitRank*

Verified™, offers a “risk score” for bitcoin wallets allowing banks, exchanges and eCommerce sites to meet traditional regulatory/compliance requirements.

During April 2019, management continued its business and marketing initiatives to increase the Company’s exposure within the Fintech/Regtech sectors, build corporate name recognition and broaden general awareness.

Despite this fall in prices, the sector is expected to experience growth in trading volumes during 2019. The cryptocurrency market, which has now entered into the longest ever bear market, is expected to remain highly volatile throughout 2019 and likely beyond.
