The common shares of First Division Ventures Inc were approved for listing on the CSE on November 27, 2018. First Division Ventures Inc. ("First Division") is a junior mineral exploration company. First Division is engaged in the business of acquiring, exploring and evaluating natural resource properties. First Division has

an option to acquire a 50% interest in the Fish Lake property, consisting of 81 lode mineral claims located in Esmeralda County in the state of Nevada, USA.

In May, the Company announced significant expansion in the size of its Temple Mountain vanadium project located in Emery county, Utah. The company has doubled the size of its land package through the staking of an additional 52 new claims to the northeast following the trend discovered through the recently completed geophysical survey.

The claims were staked by Carlin Trend based out of Elko, Nev., on behalf of the company and the claims were registered with the Bureau of Land Management (BLM) on May 13, 2019. The Temple Mountain property now encompasses 104 contiguous lode mining claims covering an area of approximately 2,150 acres or 870 hectares.

Additionally, the company announces the engagement of Khaos Media Group for investor relations/awareness. The company has entered into a month-to-month agreement with Khaos for the provisions of investor relations and advertising services in consideration for \$125,000 (U.S.) per month.

Management is currently engaged in the business of acquiring, exploring and evaluating natural resource properties.

Throughout the month of May, management has focussed efforts on completing the previously announced private placement and acquisition of EU Energy Corp.
