### **1. Report on Business**

St-Georges is developing new technologies to solve the biggest environmental problems in the mining industry. If these new technologies are successful, they should improve the financial bottom line of current mining producers. The potential success of these technologies would also involve upgrading certain current known metal resources to economic status while addressing the environmental and social acceptability issues.

The Company also explores for Nickel on the Julie Nickel Project on Quebec's North Shore & for Lithium in different areas of Quebec. Headquartered in Montreal, St-Georges' stock is listed on the CSE under the symbol SX, on the US OTC under the Symbol SXOOF and on the Frankfurt Stock Exchange under the symbol 85G1.

### **2. Other Corporate matters**

On October 12, 2016 St-Georges announced the acquisition of Le Royal Lithium project located in Quebec. The agreement establishes St-Georges' ownership at 90% against payments of 2.5 million shares and \$50,000 over 1 year and CAD \$450,000 worth of qualified exploration work on the project over the next 3 years. Furthermore, Platypus Resources (ASX: PLP) will own a carried interest of 10% of Le Royal Lithium and will provide a license for their extraction technology.

In relation to this acquisition, St-Georges issued 1.5 million common shares to the vendors on October 24, 2016 bringing the number of shares outstanding to 53,389,045.

The lawsuit is ongoing as of this date.
