The Issuer is a licensed cannabis producer pursuant to Health Canada's *Cannabis Act* and specializes in cannabis cultivation. The Issuer built and operates a state-of-the-art production facility in B.C.'s North Okanagan region and currently sells premium dried cannabis flower to wholesale partners across Canada.

The Issuer sells production on a regular basis and currently harvests 60,000 grams every 12 days or so continuously throughout the year as opposed to seasonal harvests. The Issuer's dried cannabis flower has been sold across Canada through a collaborative strain launch with Kolab Project and through other wholesale relationships.

On December 29, 2020, the Issuer reported financial results for the Fiscal Year 2020. The Issuer reported approximately \$4.6M in sales and \$1.5M in net income during the twelve month period ending August 31, 2020. The official news release can be read [here](#).

The Issuer as announced, plans to add up to an additional 30,000 square foot extension to its initial facility near Armstrong, B.C. Building permits have been approved by local officials and the Issuer is using this time to accumulate capital and build on its strong sales and profit record which in turn will support financing of the expansion.
